- The CS Leveraged Loan Index is designed to mirror the investible universe of the \$US-denominated leveraged loan market. Loans are added to the index upon issuance according to the following criteria: (1) Loans must be rated "5B" or lower. That is, the highest Moody's/S&P ratings in the index are Baa1/BB+ or Ba1/BBB+. If unrated, the initial spread level must be Libor plus 125 basis points or higher. (2) Only funded term loans are included. (3) The tenure must be at least one year.
